- (c) To undertake and conduct social service schemes for the benefit of the poor, orphans, destitutes, street-children, alcoholics, drug-addicts, physically handicapped, mentally retarded, those suffering from terminal diseases and the like.
- (d) To give food, clothing, shelter and cash grants to the orphans, poor and others in need and to grant donations for the support of the inmates of orphanages, rescue homes, rehabilitation centers and similar institutions.
- (e) To establish, construct, equip, maintain, conduct, run, develop, improve, extend orphanages, children's homes, day-care centers, night-study classes, rescue-homes, rehabilitation centers, de-addiction centers, counseling centers, guidance cells, bureaus and the like.
- (f) To establish, equip, maintain, conduct, run, develop, improve and extend, trade cells, cottage industries, production units, industrial outfits, and the like for the benefit of the poor, marginalized, neglected, handicapped and the like.
- (g) To establish, maintain, run, develop, improve, extend and to donate for and to aid in the establishment, maintenance, running, development, improvement and extension of creches, balwadis, adult-literacy centers, schools, colleges, polytechnics and other educational institutions including vocational guidance/training centers, research centers and hostels for students pursuing their studies.
- (h) To organize, conduct and assist in organizing and conduct of lectures, seminars, symposia, conventions, conferences, workshops, etc. on arts, science, commerce and other subjects of general academic interest to students.
- (i) To establish, construct, equip, maintain, conduct, run, develop, improve and extend hospitals, clinics, dispensaries, medical laboratories, research units, and similar institutions affording treatment, cure, rest, recuperation and medical relief including relief to the physically handicapped and mentally retarded.
- (j) To establish, construct, equip, maintain, conduct, run, develop, improve and extend blood banks, drug banks and to organize, run and assist in the organizing and running of free medical camps.
- (k) To provide relief in time of natural calamities like earthquakes, cyclones, floods, famines, etc.
- (l) To work in partnership with, or support other groups and organizations who subscribe to these aims and objectives.
- (m) To perform any other activities that are expedient for the furtherance of the above objects.

4. TRUSTEES:

4.1 The following persons shall be the first Trustees of the Trust:

- (a) **Mr. Khagga Venkata Rao, Founder Trustee**
- (b) **Mr. Kamkodlamane Bhaskar, Trustee**
- (c) **Mr. Tadisetty Venkateswa Rao, Trustee**

4.2 The Trustees shall be entitled to delegate to any of them such powers and duties as they think fit and proper.

- 4.3 The power of appointing new trustees shall vest with the Trustees for the time being.
- 4.4 A Trustee may resign his/her office as Trustee by giving notice in writing to his/her co-trustees.
- 4.5 If the Trustees hereby constituted or any of the Trustees or Trustee appointed as provided in this Deed shall die or leave station for more than three consecutive years or discharge or refuse or become unfit or incapable to act, then and in every such case, such Trustees or Trustee shall be deemed to have vacated his office.
- 4.6 The number of Trustees shall not at any time be less than two or more than nine.

5. TRUST PROPERTY:

The term "Trust Property" shall mean the whole or any part of the aforesaid moveable property, all additions and accretions thereto, the income thereof, the acquisitions therewith, the rights and privileges acquired, the conversion thereof in any other form, and all other property which may from time to time vest in, or come from any source to the Trust. The Trust at present has no other property that is movable or immovable.

6. POWERS, RIGHTS, DUTIES AND RESPONSIBILITIES OF THE TRUSTEES:

The Trustees shall stand and be possessed of the Trust and all the additions to the Trust Fund and all income arising there from upon the Trust and subject to their powers, rights, duties and responsibilities herein below declared concerning the same:

- 6.1 The Trustees shall be entitled to receive the annual or other income of the Trust of these presents themselves and to pay and discharge all the costs and expenses incurred in or about the administration of the Trust of these presents.
- 6.2 The Trustees shall be entitled to spend, hand over, apply or allocate the annual or other income of the Trust for the objects hereinabove mentioned in any proportion the Trustees may like or deem fit at their discretion.
- 6.3 When the Trustees decide not to spend, hand over, apply or allocate any income but to accumulate the same, the same will be accumulated for the objects hereinabove mentioned to be spent, handed over, applied or allocated at any later date.
- 6.4 The Trustees may engage in and carry on any business or businesses for and on account of the Trust established by this Deed and may invest any part of the fund or assets of the Trust in such business or businesses in the name of the Trust. In the course of such business, the Trustees may do all that is necessary for carrying on such business or businesses. They may sign contracts, open Bank Accounts, sign cheques, negotiate documents, institute legal proceedings, and do all that is necessary for the successful carrying on of the business or businesses and execution of the Trust.
- 6.5 The Trustees shall be free to invest all the monies, which shall require investment in any manner they think fit and proper without being obliged to invest the same in the investments permitted by law for the investments of the trust fund. They can invest in any immovable or moveable property or properties. They can purchase shares, securities, give loans or deposits or advances with or without securities.
- 6.6 The Trustees are hereby expressly authorized to accept gifts or money or movable or immovable property from any person or persons on such terms and conditions as may be deemed fit and proper in their discretion for the augmentation of the Trust Fund.
- 6.7 Without prejudice to the foregoing, the Trustees shall have power to do the following:

- (a) To employ clerks and other employees, brokers, bankers, lawyers, accountants and others at such remuneration as they think fit;
- (b) To delegate any power to one or more of the Trustees;
- (c) To delegate any power as they can lawfully delegate to any person and to execute such power of attorney as they think fit and proper for the purpose;
- (d) To withdraw any power or to revoke any appointment of any employee or attorney;
- (e) To let or lease any portion of any immovable property forming part of the Trust at such rent or compensation for such period and on such terms and conditions as they may think fit and proper to accept surrender of any lease, and to file suits in ejection and/or for recovery of rents and other dues;
- (f) To maintain Bank Accounts in the name of the Trust;
- (g) To appoint a proxy for voting at any of the meetings of the creditors, shareholders and/or others.

6.8 The Trustees shall have the authority to deposit the securities or investments of the Trust with the Bankers for custody and collection of interest, dividend, etc. and also to deposit the Trust Funds in the Bank Accounts opened in the name of the Trust and operated jointly by any two of the Trustees.

6.9 Any Trustees who being a professional or any firm in which he or she is a partner is engaged or employed in any professional capacity to act for this Trust or do any work for this Trust may be remunerated out of the Trust Fund by the Trustees for such professional work and he or she or such firm shall be entitled to charge this Trust for any professional services rendered to it by such trustees or by such firm.

6.10 It shall be lawful for the Trustees for the time being of these presents to reimburse themselves, himself or herself or pay and discharge out of the Trust Properties all costs, charges and expenses incurred in carrying out of these presents or in or about the execution of the Trust or powers of these presents.

6.11 The acknowledgment by the Trustees for the purchase moneys of any property hereby authorized to be sold or for any other moneys paid or for any shares, stocks, funds or securities transferred to them shall effectually discharge the person or persons paying or transferring the same, there from and from being bound to see the application or being answerable for the loss or misappropriation thereof, if any.

6.12 The Trustees shall be respectively chargeable only for such moneys or securities or other properties as they shall actually receive notwithstanding their signing any receipt for the sake of conformity and shall be answerable and be accountable only for their own acts, receipts neglects or defaults and not for others or of any bankers or of other persons with whom or into whose hands any Trust moneys or funds or securities may be deposited or come, nor for the same unless the same shall happen through their own willful default respectively.

6.13 The Trustees decision as to whether any sum, assets or shares or security received in respect of and forming part of the Trust Fund should be treated as capital or revenue income shall be final.

6.14 The Trustees shall ensure the accounts of the Trust to be maintained regularly. The accounts of the Trust for the time shall be made from the date of formation of the trust up to 31st March following the dates of the said formation. Thereafter the accounts shall be made every year from 1st April to 31st March. The accounts shall be audited by a Chartered Accountant appointed by the Trustees.

- 6.15 The Trustees shall be entitled to appoint any one of them as Managing Trustee and joint Managing Trustee and to delegate to them such powers and duties as they think fit and proper.
- 6.16 A Trustee may resign his office as Trustee by giving notice in writing to his or her co-trustees.
- 6.17 If the Trustees hereby constituted or any of them or Trustees or Trustee appointed as provided in this Deed shall die or leave station for more than three consecutive year or discharge or refuse or become unfit or incapable to act, then and in every such case, such Trustees or Trustee shall be deemed to have vacated his office.
- 6.19 The funds of the Trust shall be invested in the modes specified under the provisions of sec. 13 (1) (d) read with section 11 (5) of the Income – tax Act, 1961.
- 6.20 The investment of the funds of the Trust shall be made only in accordance with the provisions of Section 11(5) of the Income tax Act, 1961.
- 6.21 The provisions of the Trust Deed shall not be amended, altered, substituted or added without the prior consent of the jurisdictional Director of Income tax (Exemptions).
- 6.22 In case of dissolution of the Trust, the properties of the Trust will be handed over to any Society / Trust, which is registered and having objectives similar to that of this Trust and registered under Section 12(A) and 80G of the Income tax Act, 1961.
- 6.23 All acts in carrying out these presents done and carried out by a majority of the Trustees for the time being, shall be valid and effectual as if such acts had been done by all the Trustees.
- 6.24 Should there be any differences of opinion at any time among the Trustees in the execution of this Trust, the opinion of the majority shall prevail, provided that in the event of tie between them, the Managing Trustee shall have a casting vote in addition to his or her own vote.
- 6.25 It shall be lawful for the Trustees to resolve or decide by circular, and such resolution or decision shall be as effective as resolution passed at a meeting, of the Trustees.
- 6.26 The Trustees shall have power to regulate their proceedings, and if necessary to frame Rules and Regulations for any purpose and or in connection with the meetings and from time to time, to repeal, amend, add to or alter the same.

7 MANAGEMENT

- 7.1 The management of the Trust shall vest with the MANAGEMENT TRUSTEES, which shall comprise of not more than nine trustees. The Three founder Trustees shall be the first Management Trustees who shall be empowered to co-opt six more trustees to the Management Trustees. The management Trustees consist of Founder Trustees and Coopted Trustees.
- 7.2 The management Trustees shall form rules and regulations for each sub-committee/ committee/ Governing Body and clearly state their duties, power and responsibilities.

8. THE TRUSTEES:

8.1 The managing Trustee: One among the founder trustee shall be the Managing Trustee and shall be appointed from among the Three Founder Trustees within fifteen days of Registration. Only Managing Trustee is appointed as permanent Trustee/Lifetime Trustee. All other are trustees liable to retire by rotation every two years and they are eligible for reelection.

8.2 The number of TRUSTEES of the said TRUST shall not at any time be less than two and when there is only one TRUSTEE additional TRUSTEES shall forthwith be appointed PROVIDED nevertheless that the number of TRUSTEES shall not at any time exceed Nine.

8.3 ANY of the TRUSTEES may retire from the TRUST hereof by notifying his/her fellow TRUSTEES in writing of his/her intention so to do and from the date of receipt of such notification the retiring TRUSTEE shall be discharged from the TRUST hereof.

8.4 If any one of the TRUSTEE dies or becomes bankrupt, insolvent or mentally incapacitated or in the judgement or majority of the other TRUSTEES signified by them in writing under their respective hands conducts himself in a manner unbecoming of a TRUSTEE such TRUSTEE shall cease to be a TRUSTEE OF THIS TRUST.

8.5 No person shall be appointed as TRUSTEE who under the preceding clause would be lawfully unable to continue to be a TRUSTEE.

9. PRESIDENT:

He shall be elected by the General Body of the Trustees and shall preside over all the Meetings of the Trust.

The PRESIDENT shall be chief executive officer of the Trust and shall have all the powers as may be provided in the regulations to be framed from the day-to-day management of the Trust. The President shall at all times during the period of office as such devote full attention to the various activities of the trust and employ faithfully and diligently and carry out all necessary steps to ensure the advantage and efficient management of the trust. The President will be the custodian of cash and funds of the Trust and will be spent in order to fulfill the objectives of the Trust. The President with the supervision of the General Secretary will maintain accounts properly along with the vouchers. All the collections of the donations and of the free-will offerings shall be counted and verified by the President of the Trust and supported by proper receipts.

The PRESIDENT shall for services rendered are entitled to draw a monthly salary and other prerequisites as may be decided upon by the Trustees from time to time.

10. VICE PRESIDENT:

He shall be elected by the General Body of the Trustees and shall act as the President in the absence of the President.

11. GENERAL SECRETARY:

He shall be elected by the General Body of the Trustees and shall arrange for the proceedings of all the meetings of the trust. He shall arrange for the carrying out of instruction given to such meetings and attend to all statutory requirements imposed on the trust. He shall convene the meetings of the TRUST in Consultation with the PRESIDENT.

12. **TRUST NOT TO FAIL:**
